Symposium Youth Attendee Registration
for ages 14 through 17



The Florida Wildlife Rehabilitators Association believes that it is in the best interests of this organization and the rehabilitation community as a whole to foster appreciation, knowledge, and skills to as broad and diverse an audience as possible. With this goal in mind, FWRA invites the participation of select young adults at our annual Symposium. If your group or facility has a young person or persons who have demonstrated maturity and a genuine interest in wildlife rehabilitation, and you believe that this youth will benefit from attendance and participation, we invite their registration. **All Youth Attendees must adhere to the following:**

- Youth Attendees must be 14 or more years of age at the date of the Symposium.
- Each Youth Attendee must be accompanied by an adult (21 years or over) sponsor who is also attending the Symposium (the Attending Sponsor). The Attending Sponsor will at all times and in all places be responsible for the Youth Attendee's actions and deportment. Each Youth Attendee must have a unique Attending Sponsor (multiple youths cannot share the same sponsor).
- All Youth Attendees and Attending Sponsors must register for the Symposium and pay the required fees.
- The Attending Sponsor must supervise the Youth Attendee either as parent in fact, or *in loco parentis* throughout the duration of the Symposium. The Attending Sponsor must room with the Youth Attendee and must accompany the Youth Attendee at all meals, activities, field trips, and at all times throughout each day and night. The only exception is that the Youth Attendee and the Attending Sponsor may register for and attend separate classes and/or workshops presented at the same time. Except for such simultaneous attendance of different classes, both the Attending Sponsor and the Youth Attendee must register for and attend classes together.
